#### A Word about Our Workshops

CMNRP is pleased to offer a variety of educational workshops. These are open to interprofessional perinatal care providers across Eastern and South Eastern Ontario, and from outside the region.

Workshop content is based on current literature, research evidence and recommendations from various professional associations. While workshops describe current standards of care, they are not intended to dictate exclusive courses of practice: rather, they provide a foundation and direction for perinatal care. Variations and innovations that improve the quality of patient care are encouraged.

A written acknowledgement of attendance will be issued to participants. These certificates of attendance are not to be used as proof of "certification" as CMNRP is not an official certification body.

In most workshops, participants complete a knowledge test so that they can receive immediate feedback on their learning. For confidentiality purposes, the marks are given directly to participants. Therefore, if the marks are required for follow-up or performance appraisals, managers should consult the individual participants. CMNRP is not responsible for the participants' performance either during or following the programs, or for implementing remedial work. However, we are willing to consult with institutions to assist in that process.

### ACUTE CARE OF AT-RISK NEWBORNS (ACORN) PROVIDER

	CARL OF AT RISK NEW DOTHIS (ACORD) TROVIDER
TARGET AUDIENCE	This 2-day workshop is intended for all practitioners involved in the care of newborns including physicians, nurses, midwives and respiratory therapists, who want to learn concepts of neonatal assessment and stabilization using ACoRN's framework and resources.
DESCRIPTION	ACORN is a 'logical, system-based approach to gathering and organizing clinical information, establishing priorities, and intervening appropriately for infants who are unwell, or at risk for becoming unwell, in the first few hours or days post-birth' (ACORN, 2021, p. 26).
	Day 1: Review the concepts, process and content of the ACoRN program, highlighting 2nd edition updates and resources (Textbook, Essential Guide and Laminates). Didactic and simulation-based learning strategies will be used. Learners will participate in simulation-based scenarios and debriefing sessions.  Day 2: Building on Day 1, learners will be given opportunities to solidify ACoRN knowledge and concepts by participating in additional and more comprehensive simulation-based scenarios and debriefing sessions.
	PREREQUISITES: Participants who, as part of their professional role, are expected to identify or care for at-risk or unwell infants are welcome to attend as long as the following <a href="CPS ACORN">CPS ACORN</a> registration guidelines are met:  • Be a licensed or regulated healthcare professional, or student of same and; • Provide proof of current CPS NRP Provider, Instructor or Instructor Trainer status (Lessons 1-11 and Advanced ISSA)
OBJECTIVES	<ul> <li>Demonstrate knowledge of the concepts and content of ACoRN.</li> <li>Describe how the ACoRN Process and its various components are used to conduct a systematic evaluation of and organize care for at-risk or unwell newborns.</li> <li>Identify ACoRN tools and resources that facilitate the care of at-risk or unwell newborns.</li> <li>Develop working diagnoses and initiate treatments for specific neonatal conditions.</li> <li>Describe the types of support that may be required for the infant, the family and the health care team.</li> <li>Identify and prepare infants for transport to a referral facility.</li> <li>Utilize the ACoRN Process during a simulation-based learning opportunity to provide care for an at-risk or unwell infant.</li> </ul>
PREPARATION/ HANDOUTS	Mandatory preparation for the workshop includes review of the ACoRN Essential Guide and ACoRN laminates as well as successful completion of the online ACoRN exam; the ACoRN textbook (2 <sup>nd</sup> edition, 2021) should be available to all teams who register but is not a mandatory resource.  Participants must successfully complete the online examination (if not completed within 12 months of the course) and submit the 'Online Examination Certificate' prior to the workshop.
NOTES	SPECIAL NOTE: ACORN workshops will be offered in Ottawa and/or South East. Like resuscitation, stabilization of at-risk of unwell newborns is most effective when performed by a coordinated, interprofessional team. In keeping with this philosophy, priority will be given to organizations who register a minimum of 3 participants representing an interprofessional team (i.e., MD, RN, RM, RRT etc.).  A limited number of workshops will be offered 'on-site' to centres with an interprofessional
	audience. Each request will be considered on a first-come first-serve basis and be contingent upon registration and availability of the ACoRN faculty. Centres are encouraged to invite community partners to participate in the workshop. The details of the workshop, including dates, location, number of participants and fees will then be negotiated.

TARGET AUDIENCE	This program is intended for interprofessional health care providers or students of same who require NRP for their current work.
DESCRIPTION	The Neonatal Resuscitation Program is a <b>one-day (in-person)</b> workshop that consists of <b>2</b> parts:
	Review of the 8 <sup>th</sup> edition <i>Textbook of Neonatal Resuscitation (2021)</i> and successful completion of the CPS NRP online ADVANCED examination is required prior to attending the workshop.
	Participation in the workshop including skills stations, advanced integrated skills station assessment (ISSA) and a simulation and debriefing exercise.
	As of February 1, 2022, the online exam will be available for purchase from RQI through the Canadian Paediatric Society (CPS) at <a href="http://www.cps.ca/en/nrp-prn">http://www.cps.ca/en/nrp-prn</a>
OBJECTIVES	<ul> <li>Perform initial steps, bag &amp; mask ventilation, chest compressions, assist with and/or intubate, calculate medication dosages</li> <li>Demonstrate awareness of the unique challenges presented by the preterm infant</li> <li>Demonstrate communication and teamwork, in addition to appropriate interventions, in a variety of resuscitation scenarios</li> <li>Participate in a simulation and debriefing exercise</li> </ul>
PREPARATION/ HANDOUTS	Review the 8 <sup>th</sup> edition Textbook of Neonatal Resuscitation (2021)  Participants must:
	1. Complete the online <b>ADVANCED</b> NRP exam within 30 days prior to the workshop, and

### **NEONATAL RESUSCITATION PROGRAM (NRP)**

PROGRAM LEVEL	INSTRUCTOR
TARGET AUDIENCE	This <b>2-day (in-person)</b> program is intended for <b>expert-level</b> practitioners who are supported by their institution and wishes to develop teaching skills in neonatal resuscitation.
DESCRIPTION	<b>Day 1</b> : Apply principles of adult learning and development of content included in the Canadian Paediatric Society (CPS) NRP Provider course, including the creation and implementation of simulation-based learning experiences: Performance Skills Stations, Integrated Skills Stations and simulation-based scenarios for evaluation and debriefing.
	<b>Day 2</b> : Building upon Day 1, candidates will have opportunities to hone their newly acquired skills. Return demonstrations, simulation, debriefing and feedback will be the focus of the learning. Finally, discussion of the roles and responsibilities of CPS NRP Instructors and logistics of running CPS NRP Provider courses will be discussed.
	PREREQUISITES: Instructor candidates must have relevant and ongoing perinatal and/or neonatal clinical experience, and:

TARGET AUDIENCE	This program is intended for providers who care for families who experience perinatal loss (e.g. nurses, social workers, chaplains, midwives, genetic counselors, physicians, child life specialists, public health nurses, and funeral directors).
DESCRIPTION	<ul> <li>Location: Blended learning (online and Zoom)</li> <li>Event description: This workshop provides a solid foundation of theoretical and clinical knowledge to facilitate effective care of families experiencing a perinatal loss. This workshop also addresses the potential effects of perinatal loss on practitioners as a result of caring for bereaved families. When possible, a parent with lived experience will provide a guest presentation.</li> <li>Format:</li> <li>This workshop will be offered in a blended learning format and consists of 2 parts:         <ol> <li>Online modules (using Google Classroom) to be completed independently prior to the Workshop. Estimated time 3-4 hours.</li> </ol> </li> <li>Participation in a 4-hour interactive Zoom videoconference session during the afternoon of the Workshop.</li> </ul>
OBJECTIVES	<ul> <li>Describe different types of perinatal losses and outline the grief process.</li> <li>Explore the significance of perinatal loss in the lives of childbearing families.</li> <li>Discuss the role of care providers including specific interventions to support bereaved families.</li> <li>Identify the challenges associated with providing support to bereaved families.</li> <li>Identify self-care strategies for care providers and other members of the health care team who are affected by loss.</li> <li>Identify resources available for parents and caregivers.</li> </ul>
PREPARATION	Participant resources to be downloaded upon registration.
